

**A. PORT PHILLIP AND WESTERNPORT**

Piloting a vessel from the Pilot Boarding Ground to a location within Port Phillip Bay or Western Port Bay (or vice versa), will be charged at the following rates:

**B. INTERNAL MOVEMENTS**

Piloting of vessels for movements within Port Phillip Bay or Western Port Bay will be charged at the following rates plus the appropriate pilot launch transfer rate:

**PILOT LAUNCH TRANSFER:**

Use of a pilot launch for transfers of pilots, crew, or materials to or from a vessel

For Anchorages S8 to S13, G1 to G4 @ Southern Outer Anchorage	\$2,417
@ Geelong Outer Anchorage	\$3,468

Cancelled launch transfer	\$263

Applies to a launch transfer that has been ordered and cancelled with less than four(4) hours notice before the scheduled service time.

**DETENTION:**

If a pilot is delayed on a vessel longer than 2 hours due to the requirements of the vessel, a detention fee may be charged at:

\$420 per hour

**C. VARIATIONS AND CANCELLATIONS**

The Minimum Notice Period is 4 hours before the service is/was scheduled.

When an order for service is placed, varied, or cancelled with less than the Minimum Notice Period, a charge of 50% of the service fee may be charged.

**Please note that under PPSP's Terms and Conditions:**

(a) PPSP has a discretion whether to accept or reject any order, request for variation of any order or cancellation of an order (with or without minimum notice)

(b) In exercising its discretion, PPSP may consider whether you have provided PPSP with status updates in accordance with the Terms and Conditions

(c) Minimum notice is calculated by reference to the scheduled service time (not the actual service time)

(d) PPSP reserves the right to cancel a scheduled service and charge 100% of the applicable service fee if three separate variations to a scheduled service time are received

(e) Any communication to PPSP by or on behalf of the customer including initial order, request for variation of an order, or cancellation of an order will be calculated and take effect once received by PPSP. If an order is changed outside the minimum notice time a surcharge fee may apply.

**D. OTHER SERVICES**

**Second pilot**

When a second pilot is required for a large vessel, a fee of \$1,366 will be charged per movement. This charge is additional to any other applicable charge or surcharge, such as a pilot launch transfer fee or if the second pilot must be taken to/from the vessel separately to the first pilot.

Additional rates may be charged for special services, i.e., tows, slow steaming, hampered vessels. Contact us for a quote on these services.

Engine trials, compass adjusting, DF calibrations, bunkering, or any other such service will be charged at:

\$ 420 per hour

(This charge is additional to any other applicable charge or surcharge)

**DISCOUNTS & SERVICE GUARANTEES**

Volume discounts and rebates are available for those customers who enter into an agreement with PPSP. The discount levels are determined by annual spend.
